Mark Rahr, Chief of Police for the Viroqua Police Department, being first duly sworn, says that on the dates stated below, in the City of Viroqua, Vernon County, Wisconsin, the defendant did:

COUNT 1: On August 28, 2008, attempt to cause a child who had not attained 18 years of age to view or listen to sexually explicit conduct, contrary to:

Wisconsin Statute **948.055(1), 948.055(2)(b), 939.32 – ATTEMPT TO CAUSE A CHILD TO VIEW SEXUAL ACTIVITY;** A class "H" felony punishable by a maximum penalty of 3 years of imprisonment and a \$5,000.00 fine.

COUNT 2: On August 27, 2008, with knowledge of the character and content of the description or narrative, attempt to verbally communicate, by any means, a harmful description or narrative account to a child, contrary to:

Wisconsin Statute **948.11(2)(am)1, 939.32 – ATTEMPT TO EXPOSE A CHILD TO HARMFUL MATERIAL, DESCRIPTIONS OR NARRATIONS;** A class "A" misdemeanor punishable by a maximum penalty of 9 months of imprisonment and a \$10,000.00 fine.

And prays that the defendant be dealt with according to law. The basis for complainant's charge of such offense is:

Mark Rahr, your complainant, is the Chief of Police for the Viroqua Police Department, and makes this complaint in that capacity based upon information received in the ordinary course of operations of the Viroqua Police Department, and further based the investigation and observations of Viroqua Police Officer Emilee Nottestad and other law enforcement personnel, all of whom this complainant believes to be truthful and reliable.

On August 5, 2008, Viroqua Police Officer Emilee Nottestad entered Yahoo! Messenger posing as a 13 year old female with the screen name 'lacrosseemily1995'. At approximately 6:57 p.m., 'lacrosseemily1995' received an instant message from 'kevin211us' aka 'Kevin K' which led to online chat. On that same date, 'Kevin K' sent 'lacrosseemily1995' a picture of himself using Yahoo! Messenger photo sharing. During

'kevin211us' aka 'Kevin K' which led to online chat. On that same date, 'Kevin K' sent 'lacrosseemily1995' a picture of himself using Yahoo! Messenger photo sharing. During this online chat, 'lacrosseemily1995' stated that she was 13 years old and 'Kevin K' acknowledged her age and stated "I don't mind a little young as long you don't mind a little older."

'Kevin K' engaged 'lacrosseemily1995' several times over the following week and set forth below are dates and online chat that took place.

On August 5, 2008, 'Kevin K' stated that he is 28 years old and acknowledge that 'lacrosseemily1995' is 13 years of age. He also stated that he is single, bi-sexual and looking for a girlfriend. 'Kevin K' asked 'lacrosseemily1995' if she had a picture of herself that she can share with him. He stated he was from Madison.

On August 27, 2008, 'Kevin K' asked 'lacrosseemily1995' when school starts. He talked to her about sunbathing in the nude together. 'Kevin K' asked 'lacrosseemily1995' if she had a picture she could share with him and 'Kevin K' was sent a picture of a young female. 'Kevin K' began talking about body parts and stated that he is a "big fan" of the area "right above the legs". He then began asking 'lacrosseemily1995' about her sexual experience and personal information such as where she shaves, her bra size, what kind of underwear she wears and her masturbation practices. 'Kevin K' made reference to coming to see 'lacrosseemily1995' and told her that he drives a blue SUV. 'Kevin K' chatted with 'lacrosseemily1995' about sexual acts and offered to teach her how to give a "BJ" and how to "jerk a guy off". He told 'lacrosseemily1995' that he would use his "fingers, tongue and mouth to give her an orgasm". 'Kevin K' stated "I'd like to cum in ur mouth when ur giving me a BJ", put "my cock in ur pussy" and asked her "would u like to watch me sometime" after telling her that he masturbates once or twice a day. 'Kevin K' asked 'lacrosseemily1995' "when would u wanna do all this?" and asked her about her mother's work schedule, specifically the week of September 7 and September 12 and 13. 'Kevin K' asked 'lacrosseemily1995' to "hang-out" with him on September 12. He asked about calling her and asked for her address, which he then Mapquested. 'Kevin K' told 'lacrosseemily1995' that he works at the UW in Chemistry.

On August 28, 2008, 'Kevin K' told 'lacrosseemily1995' about the porn he likes to view on the internet. He again referenced when "I'm there in person" and asked 'lacrosseemily1995' if she wanted to see his penis. At 10:09 p.m., 'Kevin K' showed 'lacrosseemily1995' his penis via web cam and told her "ur welcome to see more of it if u want", and stated "I'm actually jerking it right now... feels good... probably going to cum soon too." 'Kevin K' asked 'lacrosseemily1995' "after seeing my cock r u interesting in seeing it in person" and told her "there's a lot I can show u and teach u." 'Kevin K' asked if 'lacrosseemily1995' had gotten her period yet and whether she'd have it on the date they set to meet. At 10:41 p.m., 'Kevin K' again showed his penis on web cam and in the web cam shot 'Kevin K' stood up, masturbating in front of the cam and ejaculated.

On September 3, 2008, 'Kevin K' asked 'lacrosseemily1995' about the possibility of meeting on Wednesday, September 11 or Thursday, September 12. he then did a Google search and verified information 'lacrosseemily1995' gave him regarding the Vernon County Fair and they planned a meeting for Thursday, September 12. 'Kevin K' stated "we're gonna have a lot of fun and I think u'll learn a lot." He told 'lacrosseemily1995' that he would bring rum to drink, condoms and personal lubricant.

On September 4, 2008, 'lacrosseemily1995' again referenced her age, stating that she would be 14 on her next birthday in March. 'Kevin K' asked 'lacrosseemily1995' if "Thursday's still good for u?" and stated "I'll probably be there by 8". He again asked about calling her and referenced them having sex when they meet in person.

On September 10, 2008, 'lacrosseemily1995' referenced being in the eighth grade and stated that she attends the Viroqua Middle School. 'Kevin K' stated that he was nervous about her mother coming home from work early while he is still there and asked her if she would stay in a hotel room with him. 'Kevin K' again asked 'lacrosseemily1995' about her masturbation practices, asking her if she gets wet when she masturbates and if she'd ever tasted it. He then asked "how about if I taste urs, u taste mine?... will u lick it right from my dick?" 'lacrosseemily1995' gave 'Kevin K' directions to her house and the phone number to her Tracfone.

On September 11, 2008, 'Kevin K' state "I'm nervous... cause it's illegal...how do I know you're not a cop..." and stated that there'd be no jail time involved for 'lacrosseemily1995' if she got caught. 'Kevin K' tells 'lacrosseemily1995' to call him at 608-320-6660 after her mom left for work. The phone number 'Kevin K' gave was the same phone number he had previously given her in an offline message to 'lacrosseemily1995' in case she wanted to call him.

On September 13, 2008, 'Kevin K' stated, "I was just playing along, I didn't realize it wasn't a game."

Using information 'Kevin K' provided about himself, Officer Nottestad was able to identify him as Kevin A. Kreisel and on the University of Wisconsin - Madison website she found a chemistry department employee with the first name of Kevin and last name initial of K. Officer Nottestad then requested a Wisconsin Department of Transportation (DOT) digital photo of Kevin A. Kreisel with a date of birth of 10-20-1979. The DOT photo was then compared to the photos and web cam footage 'Kevin K' had sent 'lacrosseemily1995' and the images matched. Officer Nottestad also did a search of Wisconsin Registered Vehicles and found that Kreisel owned a 2005 blue Hyundai Tucson GLS Sport Utility Vehicle with Wisconsin registration 410MKU and gave an address of 322 South Yellowstone Drive, Apt. 1, Madison, WI 53705.

On September 12, 2008, the date that 'Kevin K' and 'lacrosseemily1995' had scheduled to meet, an undercover officer called the telephone number Kreisel provided and left a


message. Kreisel did not answer or return the calls placed by the undercover officer on that date and he did not go to the designated meeting place as planned.

On September 23, 2008, Officer Nottestad obtained a Search Warrant for 322 South Yellowstone Drive, Apt. 1 in Madison. The Search Warrant also included Kreisel's registered Hyundai Tucson. At approximately 8:30 on that date, Officer Nottestad arrived at Kreisel's residence with Madison Police Department Detective Julie Johnson. Kreisel gave the officers permission to enter his residence and speak with him. Kreisel stated that there were three computers in the residence, a personal PC-emachines brand, a personal laptop-Acer brand, and his work laptop-Acer brand. Kreisel stated that his work computer was used for work, he took it back and forth every day but it was owned by him personally.

Officer Nottestad was assisted by the Madison Police Department in executing the Search Warrants of the residence and vehicle and 13 items were taken into custody.

Shortly after arriving back to the Madison Police Department West District Building, Kreisel called Detective Johnson's desk phone and asked to come in and speak with them. Kreisel arrived at the department a short time later in his own vehicle. During the interview Kreisel stated that he did not believe the person he was chatting with was really a 13 year old female so he continued the "role-playing". Kreisel stated that he did receive sexual gratification from the dialogue he had with 'lacrosseemily1995'. He stated that he did send 'lacrosseemily1995' both pictures of himself as well as a web cam feed which showed him in the nude masturbating.

When Officer Nottestad asked Kreisel about the phone included in the Search Warrant, he told her that it was a Tracfone he kept at work that he purchased for the purpose of speak with 'lacrosseemily1995'. After Officer Nottestad had Kreisel's phone in custody she previewed the dialed and received calls and observed two contacts saved in the phone 'danielle' and 'wanda'. The phone also showed a call from the undercover officer on the date of the scheduled meet.
