Count 1: POSSESSION OF CHILD PORNOGRAPHY

The above-named defendant, on or about Tuesday, August 18, 2009, in the City of Lodi, Columbia County, Wisconsin, did, having attained the age of 18, knowingly possess a motion picture of a child engaging in sexually explicit conduct, and reasonably should have known that the child was under the age of 18, contrary to sec. 948.12(1m)&(3)(a) Wis. Stats., a Class D Felony, and upon conviction may be fined not more than One Hundred Thousand Dollars (\$100,000), or imprisoned not more than twenty five (25) years, or both.

And furthermore, invoking the provisions of Wisconsin Statute Section 939.617, upon conviction the Court shall impose a bifurcated sentence including a term of initial confinement for at least three years. The Court may impose a sentence less than three years or place the person on probation upon a finding on the record that the Court finds the lesser sentence is in the best interests of the community and the public will not be harmed.

And furthermore, invoking the provisions of Wisconsin Statute 973.042(2), upon conviction for a crime under 948.05 or 948.12 and the defendant is at least 18 years of age at the time of the commission of the crime, the Court shall impose a surcharge of \$500.00 for each image or each copy of an image, as defined in 973.042(1), associated with the crime. Stats., a Class D Felony, and upon conviction may be fined not more than One Hundred Thousand Dollars (\$100,000), or imprisoned not more than twenty five (25) years, or both.

And furthermore, invoking the provisions of Wisconsin Statute Section 939.617, upon conviction the Court shall impose a bifurcated sentence including a term of initial confinement for at least three years. PROBABLE CAUSE:

Your complainant is informed by the written report of Special Agent Lisa Wilson, of the Wisconsin Department of Justice – Division of Criminal Investigation. SA Wilson reports

the following: On August 18, 2009, SA Wilson and other law enforcement officers executed a search warrant at 117 Merton Avenue, in the City of Lodi, Columbia County, Wisconsin. At that location, SA Wilson was acting as the evidence control agent. In that capacity, SA Wilson seized a laptop computer from the bedroom of JEREMY L. JOHNSON. The laptop computer was later analyzed by Computer Forensic Analyst Timothy Lokrantz. Analyst Lokrantz provided a compact disc of items recovered from the laptop computer to SA Wilson. SA Wilson reviewed the disc and observed the following motion picture video files:

- (1) File path D:\Users\Jeremy\Documents\FrostWire\Saved\ (Pthc Lolifuck) Kimmy – 14 YO New.mpg depicts a nude girl, who appears to be under the age of 14, performing fellatio on an adult male penis. The girl also rubs the penis with her hand. The adult male ejaculates onto the girl's face.
- (2) File path D:\Users\Jeremy\Documents\FrostWire\Saved\Pedo-(PTHC) 10Yo Kelle And 11Yo Girlfriend.mpg depicts two nude girls, who both appear to be under the age of 13. One of the girls appears to be performing cunnilingus on the other girl.
- (3) File path D:\Users\Jeremy\Documents\LimeWire\Saved\PTHC-G-WebCam 10yo Little Girl Fuck.mpg depicts a nude girl, who appears to be under the age of 10, and an adult male. The adult male inserts his finger into the girl's vagina. The adult male then has sexual intercourse with the girl.
- (4) File path D:\Users\Jeremy\Documents\LimeWire\Saved\Pthc – Jenny 9yo In Car With Boy.mpg depicts a partially nude boy, who appears to be under the age of 10, on top of a partially nude girl, who appears to be under the age of 13, in a car. The boy's genital area is in contact with the girl's genital area.
- (5) File path D:\Users\Jeremy\Documents\LimeWire\Saved\ (PTHC) 10 Yo Cindy – Playing With Dad.mpg depicts a clothed girl, who appears to be under the age of 11, performing fellatio on an erect adult male penis.
- (6) File path D:\Users\Jeremy\Documents\LimeWire\Saved\ (PTHC) Amy Mg 8yo (Kgirl).mpg depicts a nude girl, who appears to be under the age of 11, lying on her back with her legs spread. An adult male leans in and licks the girl's genital area.
- (7) File path D:\Users\Jeremy\Documents\LimeWire\Saved\!New! (Pthc) (Kinderkutje) 8 – 10Yo-Cd-1-3.mpg depicts a nude girl, who appears to be under the age of 13, rubbing her genital area. An adult male kneels next to the girl, on the bed, and forces the girl's head toward his penis. The girl performs fellatio on the male's penis. The male rubs his penis on the girl's genital area.

SA Wilson also reports the following: On August 18, 2009, SA Wilson spoke with JEREMY L. JOHNSON. JEREMY told SA Wilson the following: JEREMY lives at 117 Merton Avenue, in the City of Lodi, with his parents. JEREMY has a laptop computer which he keeps in his room at his parent's residence. JEREMY uses LimeWire and FrostWire to download music and videos onto his computer. JEREMY had used his computer to download adult pornography. JEREMY has used the search terms "Lolita" and "PTHC". JEREMY admitted that he kept looking at the child pornography because he was not the person in the video so he was not doing anything wrong.

Your complainant believes the statement of the defendant to be truthful and reliable inasmuch as it is against the defendant's penal interests.

Based on the foregoing, the complainant believes this complaint to be true and correct.
