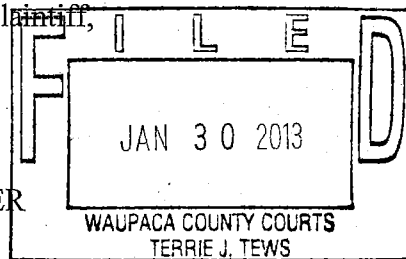


ARREST WARRANT

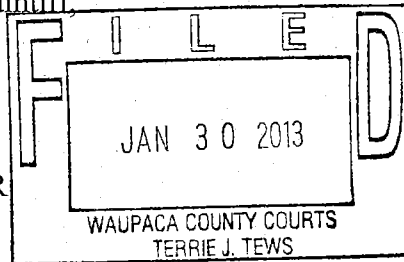

CRIMINAL COMPLAINT

COUNT 1: FIRST DEGREE SEXUAL ASSAULT, CONCEALING IDENTITY

On November 5, 1990, the above named defendant, Glendon C. Gouker, in the Village of Iola, Waupaca County, Wisconsin, did have sexual intercourse with a 20 year old adult female, without that person's consent by threat of use of an article used or fashioned to lead the victim reasonably to believe it was a dangerous weapon, contrary to Wis. Stat. (1989-90) §§ 940.225(1)(b), 939.50(3)(b), and 939.641(2).

PENALTY: Upon conviction of this offense, a Class B Felony, the defendant may be sentenced to a term of imprisonment not to exceed twenty (20) years. And further, invoking the provisions of Wis. Stats. § 939.641(2), because the defendant committed this offense while concealing his usual appearance, with the intent to make it less likely that he would be identified with the crime, the maximum penalty for the underlying crime may be increased by not more than five (5) years.

PROBABLE CAUSE:

This complaint is filed on information and belief based upon reports, documents and statements compiled by the Village of Iola Police Department, the Waupaca County Sheriff's Department, and the Wisconsin State Crime Laboratory in Madison, Wisconsin.

Your complainant has reviewed the written report of Village of Iola retired Police Chief Thomas Hansen (hereinafter Chief Hansen), a fellow law enforcement officer your complainant believes to be truthful and reliable. Chief Hansen reported that on the evening of November 5, 1990, he was notified of a reported sexual assault that occurred on that same day in the Village of Iola, Waupaca County, Wisconsin. Chief Hansen reported that he immediately responded to the residence of the alleged sexual assault victim.

Chief Hansen reported that at that location he spoke with a 20 year old female who advised that earlier that day she had gone to the Iola IGA on foot to get cereal for breakfast and was returning home around 7:40 p.m. She further stated that when she got into the area of 450 Water Street, Village of Iola, she thought she heard something in the yard at that address. She stated that she continued walking northbound on CTH J (Water Street). She further stated that when she got near the Olson Park exit, across from 500 Water Street, she thought she heard someone running behind her, turned around, and saw a man wearing a dark mask, possibly black, with an opening around the eyes, coming at her. The man had on a camouflage jacket and black gloves. The subject grabbed the 20 year old female around the neck and began dragging her down the hill into the park. The 20 year old adult female indicated that she then started screaming for help, the subject put his hand over her mouth and told her to shut up or he would kill her. She indicated that when they got to a small group of mature pine trees, the subject

grabbed the box of Cheerios she had purchased at the IGA and threw it. She stated that her attacker then got her up from the ground, still holding her around the neck, and told her not to start screaming. She reported that the subject then started walking in a westerly direction toward Lake Iola. She indicated that her attacker then forced her through a small hollow in the park and up a small hill. They then turned and went through a small tree and brush line and across two back yards still following the shore line of the lake. She related that they eventually came out onto Sunset Drive, then onto Lakeshore Drive, until they reached a small clearing. The subject then dragged the 20 year old adult female up a hill onto property owned by the Iola Community Golf Course, turned and went in a northerly direction and parallel to Sunset Drive to an area the 20 year old adult female thought was near the driving range of the course, located in the Village of Iola, County of Waupaca, State of Wisconsin. The subject then told the 20 year old adult female to "quit crying," and to "get down on your knees and put your hands on your lap." The subject then blindfolded her. The 20 year old female further reported that she then asked the subject if he was going to kill her, and the subject replied, "not if you do what I tell ya."

The 20 year old adult female further reported to Chief Hansen that the subject then said "take your mittens off, take your jacket off." The 20 year old adult female reported that she complied with the subject's order. She also stated that the subject then took her shirt and pulled it over her head and then removed her bra and made her lie down. The subject then removed her shoes. The 20 year old adult female stated she was shaking and the subject asked her if she was cold. He then rubbed her breasts and covered her stomach with whatever article of clothing she was lying on. He then unbuttoned her pants, and removed both her pants and underwear. The subject then stuck his fingers into the 20 year old adult female's vagina and asked "does that feel good?" The 20 year old adult female then reported that she was crying pretty hard and the

subject said, "do you feel this," and stuck something in her back. She stated that she thought it felt like a stick or possibly a knife. The subject then told her, "I'm not afraid to use this, not one bit. I don't care if you're warm or dead, honey. I'm just doing my job; I got paid to do this." The 20 year old adult female further reported that the subject put his penis into her vagina, and approximately two minutes later asked, "Should I come inside of you?" The 20 year old adult female replied, "please don't." The subject then stated, "maybe if you quit crying and be real good, I won't. That sounds like a deal to me, doesn't it, darling." The subject then pulled his penis out of the 20 year old adult female's vagina and said, "I didn't hurt ya, did I? I want you to know this was nothing personal, I'm just doing my job," and then patted the 20 year old adult female on the head. The subject then stated, "I don't want to hear any heat about this, because if I do, I'll be sitting outside your door the minute you come out. I know where you live." Further, the 20 year old adult female described the subject as a white male in his early 20's, approximately 6 feet tall, approximately 200 pounds, with a southern accent, wearing a camouflage jacket, black ski mask and black gloves.

Chief Hansen further reported that following his interview with the 20 year old adult female sexual assault victim the victim was transported to the Waupaca Riverside Community Hospital for collection of evidence using the Wisconsin Sexual Assault Evidence Collection Kit.

Your complainant has also reviewed a number of "Evidence/Property Custody Document" forms maintained in the normal course of business by the Village of Iola Police Department and the Waupaca County Sherriff's Department. Those documents indicate that the sexual assault evidence kit that was used to obtain evidence from the 20 year old adult female

sexual assault victim was transported to the Wisconsin State Crime Laboratory in Madison, Wisconsin for scientific analysis.

Your complainant also reviewed the written report of former Waupaca County sheriff's Department Deputy Gerald Jorgenson (hereinafter Deputy Jorgenson), a fellow law enforcement officer your complainant believes to be truthful and reliable. Deputy Jorgenson reported that he went to Taylor Field Park to investigate the crime scene of the sexual assault of the 20 year old adult female. Upon arrival at the park area at approximately 9:05 p.m. on November 5, 1990, he found a box of Cheerios cereal which the 20 year old adult female had been carrying at the time of the attack. Deputy Jorgenson photographed the Cheerios at approximately 9:12 p.m. The box of Cheerios was located approximately 50 feet from the road (Water Street) next to a tree. This area is located at the southeast side of the park, near the exit portion of the park.

Further, your complainant has reviewed the written report of then Officer Gene Goode (hereinafter Officer Goode) of the Village of Iola Police Department, who was a fellow law enforcement officer whom your complainant believes to be truthful and reliable. He reported that on November 5, 1990, the Waupaca County Sheriff's Office received of a complaint of vandalism at 450 Water Street, located in the Village of Iola, County of Waupaca, State of Wisconsin. At approximately 12:00 p.m., Officer Goode arrived at 450 Water Street and met with the complainant, Richard L. Heckenleible, II (hereinafter "Henkenlieble"), who advised Officer Goode that sometime between the hours of 1:30 p.m. on November 5, 1990, and 11:50 p.m. on November 6, 1990, someone took a knife and cut four tires on his 1970 Pontiac LeMans. Heckenleible, advised Officer Goode that he thought the person who did this was his ex-roommate, Glendon C. Gouker. Heckenleible was asked why he thought Glendon Gouker did

this, and Heckenleible stated because he owes me money for rent and he advised Glendon Gouker he would take him to court if he did not pay him. Officer Goode asked Heckenleible where Glendon Gouker lives since he was kicked out of his house, and Heckenleible stated he lives somewhere on State Street. Heckenleible further advised officer Goode that there was a path that leads to Glendon Gouker's new apartment on State Street through the woods. Heckenleible further led Officer Goode to the path in the woods, which is located directly behind Heckenleible's house to the south. Officer Goode asked Richard Heckenleible for Glendon Gouker's physical description, and Richard Heckenleible stated that Mr. Gouker is approximately 6 feet tall and weighed approximately 190 pounds. Officer Goode asked Heckenleible if Glendon Gouker talked funny, and Heckenleible stated that Glendon Gouker has a southern accent, and that Glendon Gouker is strange. Officer Goode asked Heckenleible if he recalled seeing Glendon Gouker with any camouflage clothing, and Heckenleible stated "yes, he does have camouflage clothing." Officer Goode further inquired if Glendon Gouker has any masks, and Heckenleible stated that Glendon Gouker does have a black ski mask and a camouflage ski mask. Heckenleible stated that Glendon Gouker has a lot of knives and he likes to play with them. Heckenleible further advised Officer Goode that Glendon Gouker was in his early 20's in age.

Further, your complainant has reviewed Waupaca County Circuit Court documents and records, and reports of the Village of Iola Police Department, which indicate that on November 8, 1990, a search warrant was executed on the residence and vehicle of the defendant, Glendon C. Gouker. The warrants were executed by Chief Hansen and Deputy Jorgenson at which time the following evidence was seized (partial list): one Buck hunting knife in black case; one Sharp brand hunting knife with no case and broken handle; one hunting knife, Mocra brand, no case;

one black colored leather gloves (pair); one hunting knife in sheath with H.G. Seaton" engraved on sheath; one hunting knife in sheath with EGW Knife" stamped on blade; one Schrade Old Timer hunting knife in sheath; one folding hunting knife, Case XX, black in color; another pair of black colored leather gloves; one camouflage jacket, shell green in color, and one dark colored stocking cap mask (knit).

Further, your complainant has reviewed a report maintained in the normal course of business by the Wisconsin State Crime Laboratory. The report concerns the Crime Lab's examination of evidence obtained from the 20 year old adult female's sexual assault victim that was contained in the Wisconsin Sexual Assault Evidence Collection Kit, and DNA samples taken from Defendant Gouker and the 20 year old female sexual assault victim. The report indicates that evidence from the kit, the victim, and defendant Gouker was subjected to DNA Analysis. According to said report, dated September 26, 2011, prepared by DNA Analyst Jennifer Vogt, the 20 year old sexual assault victim and defendant Glendon Gouker are included as possible contributors to the STR DNA mixture profile detected from the washing of the pubic hair standard (Item B7) taken from the 20 year old female sexual assault victim. The report further indicated that it is at least 44 trillion times more likely to observe this DNA mixture if it is a mixture of DNA from the 20 year old female sexual assault victim and Glendon Gouker than if it is a mixture of DNA from the 20 year old female sexual assault victim and a random, unrelated individual.


Your complainant has reviewed electronic records maintained in the normal course of business by the State of Wisconsin Department of Transportation. Those records indicate that defendant Glendon Gouker, who had a Wisconsin driver's license throughout 1990, moved to the State of Oklahoma on September 17, 1993. Those same records indicated that his Oklahoma

driver's license was replaced on in February of 2008 and was renewed in May of 2009. His current Oklahoma driver's license is set to expire in May of 2013.

Your complainant has also reviewed the written report of Iola Police Officer Gene Goode concerning his interview with defendant Glenden Gouker during which Gouker made statements against his penal interests. Officer Goode reports that during that interview Gouker was asked whether he has a knife, and Gouker indicated that he collects knives. When he was given the name of the 20 year old female sexual assault victim and asked if he knew her, Gouker stated "no". When asked if he owns a ski mask, Gouker stated "yes". When asked if the ski mask covered the entire face, Gouker stated "yes". When asked what color was the ski mask, Gouker stated "black."


