COMPLAINING WITNESS

Crowe/et al

The above-named complaining witness being first duly sworn states the following:

**Count 1: USE OF A COMPUTER TO FACILITATE A CHILD SEX CRIME**

The above-named defendant on or about Wednesday, March 13, 2013, Dane County, Wisconsin, did use a computerized communication system to communicate with an individual who the actor believed or had reason to believe had not attained the age of 16 years with intent to have sexual contact or sexual intercourse with the individual in violation of s. 948.02 (1) or (2), contrary to sec. 948.075(1r), 939.50(3)(c) Wis. Stats., a Class C Felony, and upon conviction may be fined not more than One Hundred Thousand Dollars (\$100,000), or imprisoned not more than forty (40) years, or both.

And furthermore, invoking the provisions of Wisconsin Statute Section 939.617(1), upon conviction the Court shall impose a bifurcated sentence including a term of initial confinement for at least five years.

**FACTS:**

Your complainant is an agent with the Wisconsin Division of Criminal Investigation and for this complaint is relying upon the official reports of Door County Sheriff Deputy Heather Bemmann, Wisconsin Dept of Justice Special Agent Anna King and Wisconsin Dept of Justice Special Agent Ronald Glaman.

STATE OF WISCONSIN - VS - Jeremy W Stegall

Deputy Bemmann reports on March 13, 2013, she was operating undercover as a juvenile female with the initials of CJ and responding to postings on [www.craigslist](http://www.craigslist). CJ replied to a posting with the title "looking for some nsa daytime fun." CJ responded to the ad and said she was 15 years old. The suspect responded asking CJ if she was a cop and that he wasn't fully against her being 15. CJ told the suspect she could get in trouble, that everyone she knows would think she's a slut or something. The suspect responded, "Well that makes two of us I could get in a ton of trouble as well so...what are u thinking? Worth the risk?" CJ asked the suspect what he was into and the suspect responded, "kissing body contact oral different positions...u?" They set a meet for 1pm on the east side of Madison. CJ asked the suspect if he had condoms or if they could pick them up. The suspect responded, "always safe." The suspect stated he was in a black truck at 1:05pm.

At 1:07pm, Agent Glaman approached a black truck in the Hyvee parking lot, located at 3801 E Washington Ave, Madison, Dane County, Wisconsin, and made contact with the driver. He was identified as Jeremy Stegall. Agent King searched Stegall's vehicle and in the center console, on the front seat, observed a small yellow tin which contained three condom packets inside.

Agent Glaman interviewed Jeremy Stegall. Stegall stated he had posted an ad on the "casual encounter men for women" section on craigslist on March 13, 2013. Stegall stated he received a response from Kristine, who identified herself as 15 years old. Stegall stated that Kristine asked if he was interested and he thought "whatever." Stegall stated he did not know what he was thinking and sometimes he just can't say no. Stegall stated he previously worked in the adult pornography industry for approximately four years as an actor/performer. Stegall stated he posts ads on craigslist regularly and has met up with "quite a few people" after posting ads.
