DEFAULT JUDGMENT AGAINST DAVID MAGELAND

Based on Court's Order for Default Judgment, which is incorporated by reference here, judgment is hereby granted in favor of the plaintiff State of Wisconsin and against the defendant David Mageland in the total amount of \$10,885.70.

The \$10,885.70 judgment is comprised of forfeitures, statutory surcharges, and costs as follows: \$7,060 for forfeitures under Wis. Stat. § 292.99(1); \$1,835.60 for the 26% penalty surcharge provided for in Wis. Stat. § 814.75(18), \$1,412.00 for the 20% environmental surcharge, the \$25 court costs pursuant to Wis. Stat. § 814.63(1), the \$13 crime laboratories and drug law enforcement surcharge pursuant to Wis. Stat. § 814.75(3), the \$68 court support services surcharge pursuant to Wis. Stat. § 814.75(2), \$70.60 for the 1% jail surcharge pursuant to Wis. Stat. § 814.75(14), and the \$21.50 justice information

system surcharge pursuant to Wis. Stat. § 814.75(15), and \$380 in costs pursuant to Wis. Stat. § 814.04(1), (2), and (6).

A payment of \$10,505.70 shall be paid by check or money order made payable to the Crawford County Clerk of Court within sixty (60) days after the date of entry of judgment, and copy of the check or money order shall be sent to Assistant Attorney General Diane L. Milligan, Wisconsin Department of Justice, Post Office Box 7857, Madison Wisconsin 53707-7857.

A payment of \$380.00 in costs/attorney fees pursuant to Wis. Stat. § 814.04(1), (2), and (6) shall be paid by check or money order made payable to the Wisconsin Department of Justice within (60) days after the date of entry of judgment, and a copy of the check or money order shall be sent to Assistant Attorney General Diane L. Milligan, Wisconsin Department of Justice, Post Office Box 7857, Madison, Wisconsin 53707-7857.

This judgment shall not be satisfied until these amounts have been paid and the injunctive relief set forth in the Order for Default Judgment has been completed.

ORDER FOR DEFAULT JUDGMENT AGAINST DAVID MAGELAND

The Court heard plaintiff's motion for default judgment against David Mageland (Mageland) on November 7, 2014. Plaintiff State of Wisconsin appeared by its attorney, Assistant Attorney General Diane L. Milligan. Defendant (~~appeared in person~~ / failed to appear after proper notice).

Based on the pleadings and the record in this case, based on arguments on the record, and for the reasons stated by the Court on the record at the hearing on the State's motion for default judgment,

IT IS HEREBY ORDERED that default judgment be entered in favor of the plaintiff State of Wisconsin and against defendant Mageland.

IT IS FURTHER ORDERED that Mageland shall:

1. Comply with the provisions in the State of Wisconsin Department of Natural Resources' Administrative Order attached to the Complaint, with the

October 15, 2013 and December 1, 2013 deadlines on page 3 of that Order being changed to March 15, 2015 and May 1, 2015, respectively;

2. Pay \$ 10,505.70 in forfeitures, statutory surcharges, and costs as follows: \$7,060.00 in forfeitures under Wis. Stat. § 292.99(1); \$1,835.60 for the 26% penalty surcharge provided for in Wis. Stat. § 814.75(18), \$1,412.00 for the 20% environmental surcharge provided for in Wis. Stat. § 814.75(12); the \$25 court costs pursuant to Wis. Stat. § 814.63(1), the \$13 crime laboratories and drug law enforcement surcharge pursuant to Wis. Stat. § 814.75(3), the \$68 court support services surcharge pursuant to Wis. Stat. § 814.75(2), \$70.60 for the 1% jail surcharge pursuant to Wis. Stat. § 814.75(14), and the \$21.50 justice information system surcharge pursuant to Wis. Stat. § 814.75(15). This payment shall be paid by check or money order made payable to the Crawford County Clerk of Court within sixty (60) days after the date of entry of judgment, and a copy of the check or money order shall be sent to Assistant Attorney General Diane L. Milligan, Wisconsin Department of Justice, Post Office Box 7857, Madison, Wisconsin 53707-7857.


3. Pay \$380.00 in costs/attorney fees pursuant to Wis. Stat. § 814.04(1), (2), and (6) by check or money order made payable to the Wisconsin Department of Justice within (60) days after the date of entry of judgment, and a copy of the check or money order shall be sent to Assistant Attorney General Diane L. Milligan, Wisconsin Department of Justice, Post Office Box 7857, Madison, Wisconsin 53707-7857.

This is a final order that disposes of the entire matter in litigation between the State and Mageland, and is intended by the Court to be an appealable order within the meaning of Wis. Stat § 808.03(1).

The clerk is directed to enter and docket the judgment accordingly, pursuant to Wis. Stat. §806.10(1).
