The Wisconsin ICAC Task Force counters the threat of offenders using the Internet or other online technology to sexually exploit children.

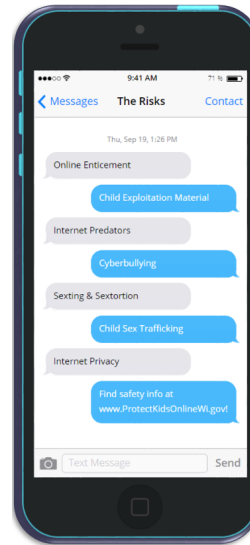

The Wisconsin ICAC Task Force investigates the information received from these CyberTips, while also patrolling the Internet for evidence associated with the production, distribution, and possession of child exploitation materials.

With assistance from our Examiners in the Digital Forensics Unit, Wisconsin ICAC is able to search the most sophisticated devices and technology for evidence. Prosecutors also work diligently to respond to and prosecute ICAC cases.
