WSCL Forensic Imaging Evidence Submission Guidelines

Effective 01/15/2022

The Wisconsin State Crime Laboratories (WSCL) works to provide quality forensic results to assist agencies throughout Wisconsin. To be both as effective and efficient as possible, we have the following guidelines in place for all Forensic Imaging Unit (FIU) case submissions.

PACKAGING REQUIREMENTS

Upon receipt, evidence items must be packaged to protect them from loss, cross contamination, and/or deleterious change.

- For physical items of evidence that are to be imaged, please submit the item(s) appropriately packaged in a sealed container.
- Digital video and/or images must be submitted on either a CD/DVD, thumb drive, or USB external hard drive and sealed and labeled as physical evidence. Each agency case should be submitted individually.

LABORATORY REQUEST DETAILS

- Provide a Transmittal of Criminal Evidence form for each agency case, complete a Request for Video and Imaging Services Form (see page 2), or provide a detailed note about the requested analysis and evidence. To avoid the influence of bias, please avoid provided unnecessary details about the case. Ensure the following information is provided in the request:
 - Contact Information- Please provide a contact name, phone number and/or email address.
 - Needs of the requests- Examples are below. If you do not see your specific needs listed, please contact the FIU at forensicimaging@doj.state.wi.us.
 - Imaging –Creating a permanent visual record of evidence with high resolution images and/or 3D scans. These
 requests can also include imaging within the infrared and/or UV spectrums when requested. It is suggested to have
 the evidence documented prior to any testing by other analytical units, for the truest and most accurate record of the
 item(s) as they were received.
 - Enhanced Video or Still Images Enhancements of license plates, vehicles of interest, persons of interest or any other items that may be depicted in an image or video file. Please provide copies of original RAW data whenever possible.
 - Media Conversion –Conversion of older media (e.g., film negatives, VHS tapes, 8mm film) to a viewable digital video or image file format.
 - **Comparison** Comparison between a questioned item depicted in a video or image to a known item, video, or image.
 - o Court Exhibits Printed enlargements or other physical or digital demonstrative exhibits.
 - Deliverables: Printed photographs and/or a link to download digital video/images.
- II. To accommodate timely results for all agencies throughout Wisconsin, WSCL works evidence in the order of submission. Rush requests impede the process; therefore, they will be accepted on a limited basis. Consult with a WSCL Criminalistics Supervisor or Forensic Case Manager with any rush request.

EVIDENCE ITEM ACCEPTANCE

Submission of items of evidence shall relate to **felony** investigations (Wis. Stat. §165.75(3)(e)). The WSCL requires at least one month prior to the jury trial date to allow the FIU time to complete analysis before the court date.

Based on the circumstances of the case, the possibility of additional analysis may be warranted. In such cases, the evidence items and analysis requested should be discussed with a Criminalistics Supervisor or Forensic Case Manager of the WSCL for consideration of acceptance: Any questions concerning the policy should be directed to:
