JUDGMENT

Based on the Stipulation between the Plaintiff State of Wisconsin and the Defendant United Liquid Waste Recycling, Inc. (United Liquid Waste), and on the Court’s Order for Judgment, judgment is granted in favor of the plaintiff State of Wisconsin, and against Defendant United Liquid Waste in the amount of

\$160,000.00. This sum is comprised of forfeitures, statutory surcharges, costs, and attorney fees as follows: forfeitures of \$98,892.86 under Wis. Stat §§ 283.91(2) and 292.99(1), the 26 percent penalty surcharge of \$25,712.14 provided for in Wis. Stat. § 814.75(18), the 20 percent environmental surcharge of \$19,778.57 provided for in Wis. Stat. § 814.75(12); the \$25.00 court costs pursuant to Wis. Stat. § 814.63(1), the \$13.00 crime laboratories and drug law enforcement surcharge pursuant to Wis. Stat. § 814.75(3), the \$68.00 court support services surcharge pursuant to Wis. Stat. § 814.75(2), the 1 percent jail surcharge of \$988.93 pursuant to Wis. Stat. § 814.75(14), the \$21.50 justice information system surcharge pursuant to Wis. Stat. § 814.75(15), and attorney fees of \$14,500.00 under Wis. Stat. §§ 283.91(5), and 292.99(2).

United Liquid Waste will pay a total of \$145,500.00 by checks payable to the Dane County Circuit Court and delivered to the Dane County Clerk of Courts, 215 South Hamilton Street, Madison, Wisconsin 53703, along with cover letters to the Court identifying the case by name and number. A copy of the cover letters shall be simultaneously mailed as proof of payment to Assistant Attorneys General Jennifer S. Limbach and Bradley J. Motl at the Wisconsin Department of Justice, Post Office Box 7857, Madison, Wisconsin 53707-7857. Payment shall be made in accordance with the following schedule:

- a) \$17,500.00 within one year after the Court signs the Order for Judgment;

- b) \$32,000.00 within two years after the Court signs the Order for Judgment;
- c) \$32,000.00 within three years after the Court signs the Order for Judgment;
- d) \$32,000.00 within four years after the Court signs the Order for Judgment; and
- e) \$32,000.00 within five years after the Court signs the Order for Judgment.

United Liquid Waste will pay \$14,500.00 in attorney fees by check payable to the Wisconsin Department of Justice and mailed to Assistant Attorneys General Jennifer S. Limbach and Bradley J. Motl at the address provided above. Payment shall be made within one year after the Court signs the Order Judgment.

The terms of the Stipulation for Judgment and Order for Judgment are incorporated into this Judgment in their entirety. This Judgment is final for purposes of appeal. The Judgment shall be docketed pursuant to Wis. Stat. § 806.10(1).
