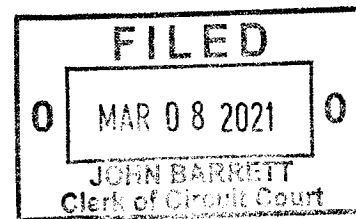

Based on the Stipulation for Judgment between the plaintiff State of Wisconsin  
and defendants Alter Trading Corporation and Miller Compressing Company, and on

the Court's Order for Judgment, judgment is granted in favor of the State of Wisconsin and against defendants Alter Trading Corporation and Miller Compressing Company in the amount of \$65,000. This sum is comprised as follows:


