### JUDGMENT

---

Based on the Stipulation for Judgment between the Plaintiff State of Wisconsin and Defendant Johannes Wakker (Wakker), and the Court's Order for Judgment, judgment is granted in favor of the State of Wisconsin and against Wakker in the amount of \$225,000.00. This sum is comprised of forfeitures, surcharges, and costs as follows: forfeitures of \$152,974.49 pursuant to Wis. Stat. § 283.91(2), a

26 percent penalty surcharge of \$39,773.37 pursuant to Wis. Stat. § 814.75(18), a 20 percent environmental surcharge of \$30,594.90 pursuant to Wis. Stat. § 814.75(12), a 1 percent jail surcharge of \$1,529.74 pursuant to Wis. Stat. § 814.75(14), \$25.00 in court costs pursuant to Wis. Stat. § 814.63(1), the \$13.00 crime laboratories and drug law enforcement surcharge pursuant to Wis. Stat. § 814.75(3), the \$68.00 court support services surcharge under Wis. Stat. § 814.75(2), and the \$21.50 justice information system surcharge under Wis. Stat. § 814.75(15).

Wakker will pay a total of \$225,000.00 by check payable to the Kewaunee County Circuit Court and delivered to the Kewaunee County Clerk of Circuit Court, 613 Dodge Street, Kewaunee, Wisconsin 54216, along with a cover letter to the Court identifying this case by name and number. A copy of the cover letter shall be simultaneously mailed as proof of payment to Assistant Attorney General Bradley J. Motl at the Wisconsin Department of Justice, Post Office Box 7857, Madison, Wisconsin 53707-7857. Payment shall be made by May 1, 2022.

The terms of the Stipulation for Judgment and Order for Judgment are incorporated into this Judgment in their entirety. This Judgment is final for the purposes of appeal. This Judgment shall be docketed pursuant to Wis. Stat. § 806.10(1).
