## OCVS Grants Team Restructure

The OCVS Grants Team has been working on ways to more effectively serve and assist our grant recipients. Beginning with the VOCA SAC Focus groups in March, the OCVS Grants Summer Regional Meetings, and the Visionary Services for Wisconsin Conference in September, the OCVS Grants Team has been garnering feedback from grant recipients in an effort to find out what agencies need and how we can be better partners.

Restructuring the OCVS Grants team is one way to recognize our own capacity issues, reduce redundancy, and improve communication with our subrecipients. **Starting on October 1, 2018**, the grants team will be assigned to agencies (not necessarily to a grant program), no matter what types of grants the agencies receive from our office. *For example, if your agency receives VOCA, VAWA, and SAVS, you will have **one** OCVS Grants Program Manager **instead of 3**.* Will soon be finalizing the assignments for our Financial Grants Specialists, Tanya Herranz and Bethzabeth Fichter.

**VOCA****VOCA Continuation Grant for the 2018-2019 Grant Cycle (begins 10/1/2018)**

As you may know, the OCVS Grants Team has been understaffed and we are doing our very best to get through the VOCA Continuation Applications. The award documents will not likely get to you before October 1, 2018. Therefore, **if you need an "Intent to Award" letter or email from Cindy Grady, please call or email her.** We will allow you to spend your 2018-2019 grant beginning on October 1<sup>st</sup>, provided that those expenses are allowable and ultimately approved in your budget. We would reserve the right to not reimburse the agency for expenses incurred that are not VOCA allowable or approved in the budget.

- **2017-2018** VOCA Grant Continuation Grants **end 9/30/18**
- 4<sup>th</sup> Quarter Reports are due 10/30/18

**SAVS**

- 3<sup>rd</sup> Quarter Program and Fiscal Reports are due 10/30/18
- Submit the program and fiscal reports in Egrants
- Contact your respective grants manager with any SAVS-related questions

**VAWA**

- Program and Fiscal Reports are due **10/30/18**
- VAWA STOP: Victim Services Non-Competitive 2019 Funding Announcement open in Egrants - **Applications are due 11/16/18!**
- VAWA SASP Non-Competitive 2019 funding announcements will be posted in Egrants soon. Current subgrantees will receive an email with details.
